EMS Issue The Credentials Committee recommended notifying Dr. John Campbell, with the Department of Public Health, of the Board's opinion that the use of paralytic agents by nurses or EMTs, practicing in the field without a physician present, is considered the unlicensed practice of medicine, and a medical director, who allows EMTs or nurses to use paralytic agents in the performance of RSI, without a physician present, is considered to be aiding and abetting the unlicensed practice of medicine. The motion was adopted.
