



QACSC / PDMP Access: Physicians and Mid-level practitioners The Credentials Committee considered a report notifying the Board that, until a solution is determined, due to a vendor change by the Prescription Drug Monitoring Program (PDMP), the prescribing history of a QACSC holder cannot be accessed by the collaborating or supervising physician; thereby, rendering the physician unable to fulfill Item 5 of the QACSC Prescribing Protocol, which states that the supervising or collaborating physician should audit the prescribing of the QACSC holder via the PDMP at least once per quarter. The Committee recommended that the Board receive the report as information and that it be duly noted that, until a solution is determined, a physician is unable to fulfill this responsibility. The motion was adopted without objection.

QACSC/LPSP Audit Reports The Credentials Committee recommended that research be conducted into the capability of the PDMP to produce audit reports such as those generated concerning physician prescribing. The motion was adopted without objection.
