Call to Order: 12:32 p.m.

With prior notice given in accordance with the Alabama Open Meetings Act, and with a quorum of fifteen members present, Board Chairman Mark H. LeQuire, M.D., convened the public portion of the meeting of the Alabama State Board of Medical Examiners.

EXECUTIVE DIRECTOR'S REPORT

Executive Director Sarah Moore reported on the following: 1) Trey Flowers, Director of Communications, is meeting with Board members to gather information in order to implement the Board's expectations in promoting the agency, communicating with stakeholders, updating the agency's website, and reformatting the agency's newsletter. Board members were encouraged to submit ideas for newsletter articles. 2) At the September meeting, Board members will be asked to select areas in which they wish to serve, such as study groups on continuing medical education, telemedicine, prescribing, advanced practice practitioners, and other identified areas of need. 3) In September, representatives from the Office of the State Auditor will conduct a physical audit of the Board's equipment. Board members and staff were reminded to have all equipment available for inventorying. 4) Carla Kruger and Lynde Crowder were recognized and congratulated for achieving a 100% compliance score from the National Practitioner Data Bank for the reporting period of January 1, 2016 through May 31, 2018.

Moore called upon Edwin Rogers, Chief Investigator, to report on the newly formed Investigative Committee, comprised of investigative staff, that is tasked with the preliminary review of investigative cases in order to facilitate disposition of the case. Investigator Rogers gave a statistical report on the disposition of recent cases.

Administrative Rules Chapter 540-X-8, Advanced Practice Nursing: 540-X-8-.03; .05.1; .06; .12; .17; .19.1; and .20 The Credentials Committee recommended that Administrative Rules Chapter 540-X-8, Advanced Practice Nursing: 540-X-8-.03; .05.1; .06; .12; .17; .19.1; and .20 be approved for final adoption. The motion was adopted without objection.

Administrative Rule Chapter 540-X-4, Appendix C, Dispensing Physician Registration Form The Credentials Committee recommended that Administrative Rule Chapter 540-X-4, Appendix C, be approved for publication in the *Alabama Administrative Monthly* for public comment. The motion was adopted without objection.

Alabama Board of Pharmacy Re: HB 35 / Act 2019-368 – Physician/Pharmacist Collaboration After consideration of Act 2019-368, and correspondence from the Alabama Board of Pharmacy, the Credentials Committee recommended that: 1) the Board proceed with developing rules for physician/pharmacist collaboration; 2) the resolution seeking an opinion from Attorney General Steve Marshall be approved; 3) when published, the Board submit public comments concerning the Board of Pharmacy's proposed physician/pharmacist collaboration rules; and 4) a reply be sent to the Board of Pharmacy's correspondence. The motion was adopted without objection.

Continuing Medical Education Courses for the Calendar Year 2020 After consideration of correspondence from Mark Jackson, the Executive Director of the Medical Association of the State of Alabama, the Credentials Committee recommended deferring this item to the September agenda. The motion was adopted without objection.

Member Report: Dick Owens, M.D. – Alabama Medical Directors Association Annual Conference The Credentials Committee recommended deferring for a report from Dr. Owens.

Dr. Owens reported that the Alabama Medical Directors Association Annual Conference was successful and informative.

Dr. Owens reported that, following the conference, several physician attendees had questions concerning the Board of Medical Examiners' prescribing rules and rules concerning collaborative practice requirements within a nursing home setting. A suggestion was made to include articles related to these topics in upcoming newsletters. The oral report presented by Dr. Owens was received as information.

Member Report: Amanda J. Williams, M.D. – MAT Working Group The Credentials Committee recommended deferring for a report from Dr. Williams.

Dr. Williams reported that the MAT Working Group has been conducting research to aid in the drafting of rules, and that the directives in the MAT Act have been assigned to members to draft rules for each specific directive. The oral report presented by Dr. Williams was received as information.

Tri-Regulator Symposium After consideration of an invitation from the Federation of State Medical Boards to send two Board representatives to the biennial Tri-Regulator Symposium, the

Credentials Committee recommended that Patrick J. O'Neill, M.D., and Dick Owens, M.D., be approved to attend as representatives of the Board. The motion was adopted without objection.




