

Ellen Barbour, PA / William Scott, M.D. The Credentials Committee recommended approval of the P.A. registration application including, with standard language previously approved by the Board, the request to train the P.A. to perform lumbar puncture and tap shunts, and number twenty-three on the P.A. formulary, birth control drugs and devices. The Committee recommended approval of the request to train the P.A. to perform ventriculostomy removal and intracranial pressure monitor bolt removal with the adoption of standard language which states that, for each skill, documentation of five supervised procedures must be submitted for Board approval. The Committee recommended that the request to allow the P.A. to perform halo pin placement be denied. The motion was adopted without objection.

Jim Blan, PA / Marion Sennett, M.D. The Credentials Committee recommended approval of the P.A. registration application including the request to allow the P.A. to assist with and monitor hyperbaric therapy. The Committee recommended that the standard language for hyperbaric therapy be amended to read as follows: A physician assistant may administer and monitor hyperbaric therapy only after the physician has conducted an initial evaluation of the patient and has prescribed the hyperbaric treatment. The hyperbaric physician must be readily available, which the Board defines for this specific procedure to mean the physician could arrive at the chamber facility within five minutes of being summoned and in doing so, would not place in jeopardy any other patient presently under their care. The motion was adopted without objection.

Sylvia Eldridge, PA / Melanie Petro, M.D. The Credentials Committee recommended approval of the P.A. registration application including, with standard language previously approved by the Board, number twenty-three on the P.A. formulary, birth control drugs and devices. The Committee recommended that the request to train the P.A. to perform endovenous ablation of incompetent saphenous vein, micro-phlebectomy, and sclerotherapy be withdrawn at the request of Dr. Petro. 




