The Committee recommended that, upon final adoption, the amended rule be sent to all licensed physicians and that any physician previously registered to perform office-based surgery be notified to re-register using the amended registration form. The motion was adopted without objection.

Administrative Rule 540-X-14-.14, Reinstatement After Inactivation of License The Credentials Committee recommended that the amendment to Administrative Rule 540-X-14-.14, increasing the continuing medical education requirement to 25 hours, be approved for final adoption. 


